## Cancellation Terms - LPC Law will charge:

- 100% of the fee and expenses if you cancel LPC Law's attendance any time after 5:00pm on the business day before the hearing;
- 100% of the fee for a Fast Track or Intermediate Track Trial which is removed
- from the list, or settled, either on the hearing date or 1 day before the hearing date;

- 50% of the fee if LPC Law has received papers and you cancel on the business day before any other hearing to be attended by Solicitor/Coursel.
